2 Abstract

This specification identifies the common Quote use cases and attributes needed to support intercarrier Quote management. It supports the requirements defined in the MEF Lifecycle Service Orchestration (LSO) Reference Architecture and Framework (MEF 55.1 [9], "LSO RA") requirements for Quotes over the Sonata Interface Reference Point (interactions between a Service Provider and a Partner). Information contained within this specification will be utilized by both Buyer and Seller for the development of automated API based interaction.



3 Terminology and Acronyms

This section defines the terms used in this specification. In many cases, the normative definitions to terms are found in other documents. In these cases, the third column is used to provide the reference that is controlling, in other MEF or external documents.

In addition, terms that are defined in MEF 10.3 [4], MEF 12.2 [5], MEF 26.2 [6], MEF 50.1 [7], MEF 51.1 [8], MEF 55.1 [9], MEF 57.1 [10], and MEF 79 [11] are included in this document by reference and are not repeated in the table below.

4 Scope

This specification defines the process for MEF Quote Management between a Seller and Buyer. This specification is limited to the business process requirements depicted as Use Cases and attribute definitions needed for Quote Management.



5 Compliance Levels

The key words "MUST", "MUST NOT", "REQUIRED", "SHALL", "SHALL NOT", "SHOULD", "SHOULD NOT", "RECOMMENDED", "NOT RECOMMENDED", "MAY", and "OPTIONAL" in this specification are to be interpreted as described in BCP 14 (RFC 2119, RFC 8174) when, and only when, they appear in all capitals, as shown here. All key words must be in bold text.

Items that are **REQUIRED** (contain the words **MUST** or **MUST NOT**) are labeled as **[Rx]** for required. Items that are **RECOMMENDED** (contain the words **SHOULD** or **SHOULD NOT**) are labeled as **[Dx]** for desirable. Items that are **OPTIONAL** (contain the words **MAY** or **OPTIONAL**) are labeled as **[Ox]** for optional.



6 Introduction

This specification defines the business requirements and process-related guidelines for the Quote process over the Sonata Interface Reference Point. The Sonata Interface Reference Point is defined in MEF 55.1 [9] as the Management Interface Reference Point supporting the management and operations interactions (e.g. ordering, billing, trouble management, etc.) between two network providers (e.g., Service Provider Domain and Partner Domain). The scope of this specification is limited to interactions between these parties; within this specification, they are referred to as the "Buyer" and the "Seller". A Buyer is defined as the organization acting as the customer in a transaction over a Sonata Interface Reference Point (Service Provider <-> Partner). A Seller is defined as the organization acting as the supplier in a transaction over a Sonata Interface Reference Point (Service Provider <-> Partner).

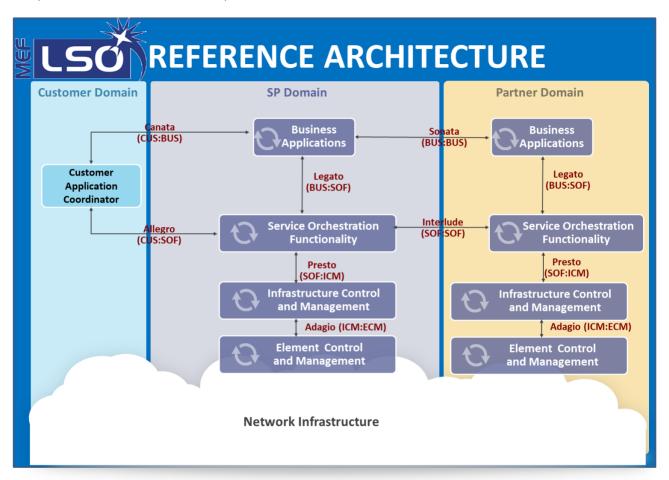


Figure 1 – LSO Reference Architecture

Within this document the following terms are used with the definition as specified below:

Notification - A message sent from the Seller to the Buyer to inform them of an event that has occurred in regard to a specific instance of a Quote. The attributes that are contained within a notification are specified within this document.



Request - A message passed from one party to the other that initiates a process. The attributes that are contained within a Request are specified within this document.

Response - A message returned by the party receiving the Request. The attributes that are contained within a Response are specified within this document.

Immediate Quote Response - A Seller's response to the Buyer's Create Quote request, whereby the Seller responds immediately with the results of the Create Quote request or indicates that the request cannot be processed. The Seller's response includes Quote and Quote Item attributes as specified.

Deferred Quote Response - A Seller's response to a Buyer's Create Quote request whereby the Seller immediately acknowledges that the Create Quote request was received with a response that includes a minimum set of Quote and Quote Item attributes. Over time, the Seller handles the Buyer's Create Quote request generating a quote and sends notifications to update the Buyer on the status of the (assuming the Buyer has subscribed to receive the notifications).

Quote – A Quote is the Seller's response to a Buyer's Create Quote request. A completed Quote may contain pricing information for the Quote Items included in the Buyer's request. A Quote is considered completed when the state of the Quote is one of the completion states as shown in Table 14 and the state of each Quote Item is one of the following:

- ANSWERED
- ABANDONED
- CANCELLED
- ORDERABLE
- ORDERABLE_ALTERNATE
- REJECTED
- UNABLE_TO_PROVIDE

The Buyer requests a Quote for the delivery of one or more of the Seller's Product Offerings or for an action to be performed on an existing Product. The terms Product Offerings and Products are defined in MEF 79 [11]. For a new installation, the Buyer references a Product Offering. If the Buyer is requesting a Quote to change or disconnect one of their existing products that is in the Seller's Product Inventory, the Buyer references the Product in the Seller's Product Inventory using the Product Identifier. A Buyer might request a Quote for a disconnect to determine if there are any termination charges.

There are 2 associated "patterns" of interaction between the Buyer and Seller when the Buyer issues a Create Quote request:

- 1. The Seller may respond immediately with the results of the request. This is called an Immediate Quote Response.
- 2. The Seller may acknowledge that the request has been received, but will not complete processing it immediately, and send notifications to update the Buyer on the status



(assuming the Buyer has subscribed to receive the notifications). This is called a Deferred Quote Response.

Note: The Buyer may retrieve the Quote at any time to obtain status and details on the Quote.

The Seller may indicate that it is not possible to process the request (immediately or after initiating processing) if the Product Offering is not supported at a requested location, does not support the requested attributes, or for other exceptions.

A Buyer may request a Quote of either a Budgetary or Firm Quote Level using the Buyer Requested Quote Level Quote attribute. All Quote Items contained in a Quote have the same Buyer Requested Quote Level.

A Seller returns a Budgetary Quote if the Buyer requested a Budgetary Quote Level.

A Seller returns a Firm or Firm – Subject to Feasibility Check Quote if the Buyer requested a Firm Quote Level.

A Budgetary Quote Level provides estimated charges for the product install, change, or disconnect. A Budgetary level Quote might be requested by a Buyer during negotiations with a customer for a product. The Buyer is simply seeking a high-level estimate of the cost associated with the service. The Seller must return a Budgetary Quote if the Buyer requests a Budgetary Quote Level.

A Buyer requests a Quote having a Quote Level of Firm using the Buyer Requested Quote Level attribute when committed charges are needed. As an example, if the Buyer is trying to provide pricing to an end customer, the Buyer may require firm recurring charges and if possible, NRCs to provide the end customer with committed pricing.

A Seller responds with a Firm Level Quote with committed recurring charges and, where applicable, committed NRCs for the product install, change, or disconnect can be provided. When the Seller responds with a Firm Level Quote, this represents a commitment to the Buyer that the pricing will not change unless there are additional actions requested by the Buyer such as an Expedite request.

A Firm - Subject to Feasibility Check level allows the Seller to provide an indication of the pricing without the commitment of a Firm Quote Level. The Firm – Subject to Feasibility Check level Quote includes committed recurring charges and a combination of committed and estimated NRCs. Additional NRCs may be added during fulfillment as costs are identified. This can only be done with Quotes with the Quote Level of Firm – Subject to Feasibility Check.

For each Requested Quote Level specified by the Buyer, there are different states that the Seller's Quote can be in and provide the Buyer with some or all requested pricing information. The relationship between Quote Level and Quote State are described below:

- Buyer Requested Quote Level FIRM
 - o IN_PROGRESS_DRAFT the Quote is only partially finalized



- ORDERABLE pricing is finalized, and all attributes match Buyer's request
- ORDERABLE_ALTERNATE pricing is finalized and not all attributes match the Buyer's request
- Buyer Requested Level BUDGETARY
 - ANSWERED Budgetary pricing is finalized

To fully define the business interactions associated with inter-carrier quotes, this specification is focused on the following key areas:

- Quote Management Use Cases and Business Process Definitions
- Specific Quote Attributes supported in this specification
- Process Flows for Quotes and Quote Items
- Notifications of events that occur during processing of the Quote



7 Quote Use Cases and Business Process Definitions

7.1 High-Level Use Cases

This section provides the complete set of Use Cases needed to support Quote Management and expands on the Quote process defined in MEF 50.1 [7]. These Use Cases are based on business process standards of interactions between Buyers and Sellers of Products. The specific attributes associated with each Use Case are defined in section 8. Prior arrangements for Buyer authentication, security verification, and system interface requirements are not addressed within these use cases. Onboarding must take place between the Buyer and Seller prior to applying the Quote process described in the Use Cases described in this section.

The Buyer might have performed an Address or Site check, or a Product Offering Qualification (POQ) as specified in MEF 79 [11] prior to the process of requesting a Quote. The Seller may mandate that every request for an installation or change include an Address Identifier, Site Identifier where possible, and/or POQ Identifier, and will reject the Quote request if those identifiers are not provided by the Buyer. The Quote functionality is not specific to any particular Product or Product Offering, and thus the Buyer is able to get a Quote on any of the Products and Product Offerings available to the Buyer that are supported by the Seller. The characteristics of the product are found in its associated Product Specifications and Product Offerings.

Figure 2 shows the Sonata Pre-Order and Order functions:

- Address Validation
- Site Retrieval
- Product Offering Qualification
- Quote
- Product Order

The use cases within this document support Quote Management. Quote Management allows the Buyer to submit a request to find out how much the installation of an instance of a product offering, an update to an existing Product, or a disconnect of an existing Product will cost. The Seller Quote contains the prices for each product or product offering included within the request.

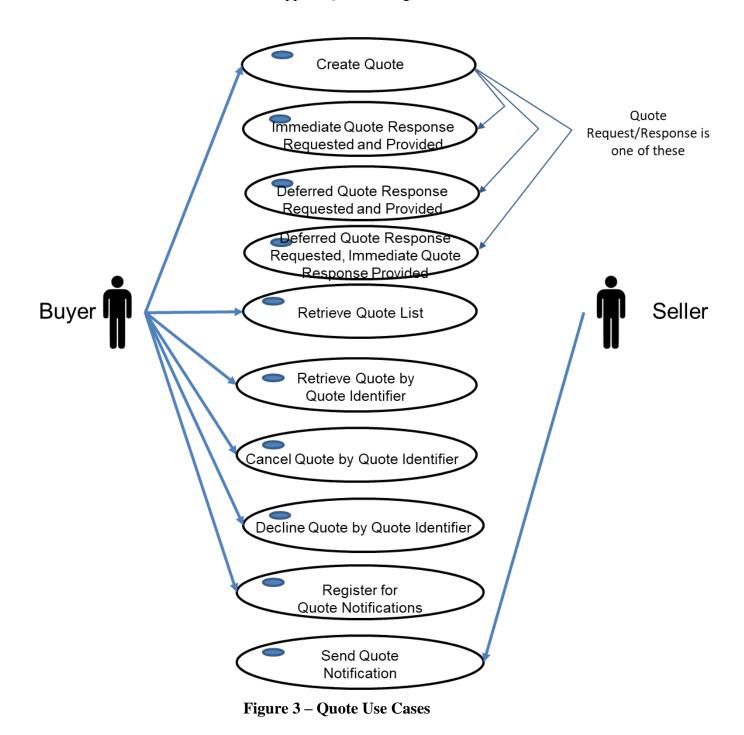
The Buyer may request, and the Seller may offer either an Immediate response or a Deferred response. An Immediate response is returned quickly, normally < 30 seconds from receiving the request. The Immediate response includes the Seller's Quote. A Deferred response allows the Seller some time period, days, weeks, etc., to complete the request. For a Deferred response, the Seller responds immediately with the attributes specified in this document and then provides



notifications to update the status of the Quote process. The Buyer can specify in their request and the Seller is required to offer either an Immediate response or a Deferred response.

7.2 Quote Use Cases

This section defines the use cases that support Quote Management.

The Buyer being on-boarded with the Seller is a Pre-Condition for all Use Cases. The on-boarding process includes the Buyer and Seller agreeing to several items including the language used for communication between the parties and the currency type used for price information.

- [D1] For all Addresses that have not been validated, a Buyer SHOULD initiate a Validate Address request, to get the Seller's full details associated with this Address prior to submitting a Create Quote request.
- [D2] For all Addresses that have been validated, the Buyer SHOULD use the Seller's Address Identifier to describe the location when submitting a Create Quote request and a Service Site Identifier does not exist.

A Seller assigns a Site Identifier to an address at some point in the POQ, Quote, or Product Order process. This is dependent upon the Seller and their processes. If a Site Identifier has been assigned by the Seller, then the following requirements ([D3], [D4]) apply.



- [D3] After validating an Address, a Buyer SHOULD initiate a Retrieve Service Site List request and obtain the Seller's Service Site Identifiers for all Service Sites at the validated Address prior to submitting a Create Quote request.
- [D4] Once the Buyer has obtained the Service Site Identifier of the Service Site, then for all subsequent operations related to this Service Site, the Buyer SHOULD use the Seller's Service Site Identifier to reference this Service Site when submitting a Create Quote request.

7.2.1 Use Case 1a Create Quote Request, Immediate Quote Response Provided

9 Quote Requirements

This section defines the requirements related to Quotes Use Cases for both Buyers and Sellers.

9.1 Create Quote

The Service Attributes and requirements for the Buyer's request and the Seller's response and Quote are defined in the following sections.

- [R11] The Seller MUST support either Use Case 1a or 1b.
- [O2] The Seller MAY support Use Cases 1a, 1b, and 1c.

9.1.1 Buyer Create Quote Request

This section contains the Service Attributes and requirements for the Buyer's Create Quote request for Use Case 1a, 1b, and 1c.

9.1.1.1 Common Requirements

- [R12] This section contains the requirements for Use Case 1a, 1b, and 1c. which are common to all Quote Item Product Actions. A Buyer MUST include at least one Quote Item in a Create Quote request.
- [R13] A Buyer requesting a Quote MUST include the following attributes as defined in Table 14:
 - Buyer Requested Quote Level
 - Quote Item(s)
 - Immediate Quote Response
- [O3] The Buyer's Create Quote request MAY contain the following attributes as defined in Table 14:
 - Buyer Quote Identifier
 - Project Identifier
 - Description
 - Notes
- [O4] The Buyer MAY include the Agreement attribute as defined in Table 15.
- **[R14]** The Buyer **MUST** specify the following attributes in Table 15 for each Quote Item in the Create Quote request:



- Quote Item Reference Number
- Quote Item Product Action
- [R15] If the Immediate Quote Response is FALSE, the Buyer MUST include the Quote Item Technical Contact attribute in Table 15 for each Quote Item in the Buyer's Create Quote request.
- [R16] If the Immediate Quote Response is FALSE, the Buyer MUST include the Buyer Contact Information.
- [R17] If the Buyer Create Quote request specifies the Immediate Quote Response of FALSE, the Buyer MUST specify the Requested Quote Completion Date defined in Table 14.
- **[R18]** If the Buyer has specified Immediate Quote Response to be TRUE, then the Seller **MUST** ignore the Requested Quote Completion Date attribute if it is specified by the Buyer.
- [O5] The Seller MAY make the POQ attribute defined in Table 15 mandatory for a Buyer Create Quote request.
- [CR1]<[O5] The Buyer MUST provide the valid POQ Identifier and POQ Item Identifier in the Create Quote request as defined in Table 23 for each Quote Item if required by the Seller.
- [R19] If a Quote Item has a relationship to another Quote Item, the attributes in Table 19 MUST be included in the Create Quote request.
- [R20] If a Quote Item has a relationship to a Product, the attributes in Table 20 MUST be included in the Create Quote request.
- [O6] The Buyer Create Quote request MAY include the following attributes for each Quote Item as defined in Table 15:
 - Requested Quote Item Installation Interval
 - Quote Item Deal Reference
 - Quote Item Note
 - Requested Quote Item Term

9.1.1.2 Quote Item Product Action – INSTALL

The requirements that are applicable for a Quote Item in a Buyer's Create Quote request with Quote Item Product Action INSTALL are defined in this section.

[R21] The Buyer Create Quote request MUST include the following attributes for each Quote Item as defined in Table 15 when Quote Item Product Action is INSTALL:



- Product Offering Identifier
- Product Specific Attributes
- [R22] If the Buyer includes the Requested Quote Item Installation Interval in the Create Quote request and they completed a POQ prior to submitting the Create Quote request, the Requested Quote Item Installation Interval MUST be longer or equal to the interval returned in the referenced POQ Item or Alternate Product Proposal.

Note: if the Buyer includes the Requested Quote Item Installation Interval in the Create Quote request and they have not completed a POQ prior to submitting the Create Quote request, the Requested Quote Item Installation Interval may be any value allowed by the Seller.

- [R23] If a Quote Item refers to a Product Offering for which a location is required by the Product Specification, the Buyer Create Quote request MUST include all the Place Relationship attributes as described in Table 24 for that Quote Item.
- [R24] If the Quote Item requires a Place Relationship and the Immediate Quote Response is FALSE, the Buyer MUST include the Quote Item Location Contact for that Quote Item.
- [R25] For each Quote Item for which the Buyer wants to select an Alternate Product Proposal included in the response of the POQ linked to the Quote Item, the Buyer MUST include a valid POQ Item Identifier and Alternate Product Proposal Identifier attribute as described in Table 23.
- [R26] If the Buyer does not desire to select an Alternate Product in their Create Quote request, they MUST NOT include the Alternate Product Proposal Identifier attribute in Table 23.
- [R27] If Quote Item Product Action is INSTALL, the Buyer MUST NOT specify the Product Identifier attribute in Table 15.
- [O7] The Buyer Create Quote request MAY contain any of the other attributes in Table 15 marked as Set by Buyer.

9.1.1.3 Quote Item Product Action - CHANGE

The requirements that are applicable for a Quote Item with Quote Item Product Action CHANGE are defined in this section.

- [R28] The Buyer Create Order Request MUST include the following attributes for each Quote Item with Quote Item Product Action = CHANGE:
 - Product Identifier
 - Product Specific Attributes
- [O8] The Buyer Create Quote request MAY include Requested Quote Item Term attribute described in Table 15 when Quote Item Product Action = CHANGE.



[CR2]<[O8]If the Buyer includes the Requested Quote Item Installation Interval in the Create Quote request, they MUST be ≥ to the interval returned in the referenced POQ.

Note: if the Buyer includes the Requested Quote Item Installation Interval in the Create Quote request and they have not completed a POQ prior to submitting the Create Quote request, the Requested Quote Item Installation Interval may be any value allowed by the Seller.

[R29] The Buyer Create Quote request MUST NOT include the Product Offering Identifier for each Quote Item with a Quote Item Product Action = CHANGE.

9.1.1.4 Quote Item Product Action – DISCONNECT

The requirements that are applicable for a Quote Item with Quote Item Product Action DISCONNECT are defined in this section.

It is unlikely that a Quote is required for a Quote Item Product Action of DISCONNECT. The requirements in this section only apply in the event that the Buyer prefers to request a Quote rather than use the Charge Process defined for Product Order.

- [R30] If the Quote Item Product Action is DISCONNECT, the Buyer MUST specify the Product Identifier as described in Table 15.
- **[R31]** If the Quote Item Product Action is DISCONNECT, the Buyer **MUST NOT** specify the following attributes in Table 15:
 - Product Offering Identifier
 - Product Specific Attributes
 - Product Relationship
 - Quote Item Relationship
- [R32] The Requested Quote Item Installation Interval MUST be ≥ the Installation Interval identified in the referenced POQ/POQ Item via the Installation Interval Unit and the Installation Interval Value as described in MEF 79 [11].

Note: if the Buyer includes the Requested Quote Item Installation Interval in the Create Quote request and they have not completed a POQ prior to submitting the Create Quote request, the Requested Quote Item Installation Interval may be any value allowed by the Seller.

9.1.2 Seller Create Quote Response and Quote Attributes

This section contains the attributes with which the Seller answers the Buyer's Create Quote request.

If the Immediate Quote Response is TRUE in the Buyer's Create Quote request, the Seller's response includes the Seller's Quote including the Seller's Quote Identifier.



If the Immediate Quote Response is FALSE in the Buyer's Create Quote request and the Seller is providing a Deferred Quote Response (see section 6), the Seller's response includes at least the Seller Quote Identifier, and the Seller provides their Quote at a later time. The Buyer retrieves the Quote using the Retrieve Quote by Quote Identifier Use Case.

If the Immediate Quote Response is FALSE in the Buyer's Create Quote request and the Seller opts to provide an Immediate Quote Response, the response includes the Seller's Quote including the Seller Quote Identifier.

9.1.2.1 Common Requirements for Immediate and Deferred Quote Response

[R33] When providing a response to a Create Quote request the Seller MUST specify the Seller Response Code attribute shown in Table 13.

The following requirements apply if the Seller Response Code does not indicate success.

[R34] If the Seller Response Code does not indicate success, the Seller MUST NOT specify any of the following attributes in Table 14 in the response: Seller Quote Identifier, Quote State, Seller Contact Information, and Quote Items.

The following requirements apply when the Seller Response Code indicates success and apply to the Seller's HTTP Response as described in section 6 whether an Immediate or Deferred Response have been requested.

- [R35] When providing a response to a Create Quote request, the Seller MUST specify the Seller Quote Identifier attribute in Table 14.
- [R36] The Seller's response MUST echo back all attributes and values set by the Buyer in their Create Quote request.
- [R37] The Seller's response MUST specify the Seller Contact Information attribute in Table 14.
- [R38] The Seller's response MUST contain each Quote Item included in the Buyer's Create Quote request.
- [R39] The Seller's response MUST contain the Quote Request Date as described in Table 14.
- [O9] The Seller's response MAY contain Notes as described in Table 14.
- [O10] The Seller's response MAY contain Quote Item Notes as described in Table 15.

The following requirements apply to the Seller's Quote as described in section 6.

- [R40] For a Create Quote request with a Buyer Requested Quote Level of FIRM, the Seller's Quote MUST contain the Quote Level which is either FIRM or FIRM_SUBJECT_TO_FEASIBILITY_CHECK.
- [R41] The Quote Level MUST be FIRM_SUBJECT_TO_FEASIBILITY_CHECK if any of the Quote Items in the Quote has the Subject to Feasibility Check attribute set to TRUE.



- [R42] For a Create Quote request with a Buyer Requested Quote Level of BUDGETARY, the Seller's Quote MUST contain a Quote Level of BUDGETARY.
- [R43] The Seller's Quote MUST specify the Seller Contact Information attribute in Table 14.
- [R44] The Seller MUST specify the Quote State attribute for their Quote as described in section 10.
- [R45] Each Quote Item in the Seller's Quote MUST correspond to one and only one Quote Item in the Buyer's Create Quote request.
- [R46] The Seller MUST specify the Quote Item State attribute for each Quote Item their Quote as described in section 10.
- [R47] For each Quote Item in the Buyer's Create Quote request that contains a Requested Quote Item Installation Interval, the Seller's Quote MUST contain a Quote Item Installation Interval that is ≤ the Buyer's Requested Quote Item Installation Interval if the Quote Item State is ORDERABLE or ANSWERED.
- [R48] For each Quote Item in the Buyer's Create Quote request that contains a Requested Quote Item Installation Interval if the Seller's Quote contains a Quote Item Installation Interval that is > the Buyer's Requested Quote Item Installation Interval the Quote Item State MUST be ORDERABLE_ALTERNATE.
- [R49] For each Quote Item in the Buyer's Create Quote request that does not contain a Requested Quote Item Installation Interval the Seller's Quote MUST contain a Quote Item Installation Interval if the Quote State is ANSWERED, ORDERABLE, or ORDERABLE_ALTERNATE.
- [R50] If the Seller's Quote is in UNABLE_TO_PROVIDE, REJECTED, ANSWERED, ORDERABLE, ORDERABLE_ALTERNATE, or CANCELLED Quote State, all Quote Items within the Create Quote request MUST be in a terminal state.
- [R51] If the Seller is unable to provide a Quote for a Quote Item that matches the Buyer Requested Quote Level, the Seller MUST set the Quote Item State attribute for that Quote Item to UNABLE_TO_PROVIDE.
- [R52] If the Quote Item State of a Quote Item is ABANDONED, the Seller MUST NOT specify the Quote Item Installation Interval attribute as specified in Table 15for that Quote Item.
- [R53] If the Quote state indicates ORDERABLE_ALTERNATE at least one of the Quote Items MUST indicate a Quote Item State of ORDERABLE_ALTERNATE.
- [R54] If the Seller's Quote moves to the ANSWERED state, the Seller MUST make available the following Quote Item attributes:
 - Quote Item State

- Quote Item Term
- Quote Item Installation Interval

The following requirements apply to pricing as shown in Table 17, Table 18, and Table 25 and apply only if the Seller Response Code indicates success.

- [O11] The Seller MAY provide at least one Quote Item Price with a Quote Item Price Type of NON_RECURRING if the Non-Recurring Charge is known for each Quote Item in IN_PROGRESS_DRAFT, ANSWERED, ORDERABLE, or ORDERABLE_ALTERNATE state including the following attributes shown in Table 18:
 - Quote Item Price Name
 - Quote Item Price Type
 - Quote Item Price Amount
- [O12] The Seller MAY provide a Quote Item Price for each Quote Item in IN_PROGRESS_DRAFT, ANSWERED, ORDERABLE, or ORDERABLE_ALTERNATE state including the following attributes shown in Table 18 and Table 25:
 - Quote Item Price Description
 - Price Tax Rate
 - Price Tax Included Amount
- [R56] If the Quote Item Price Type is RECURRING for a Quote Item Price, the Seller MUST include the Quote Item Price Recurring Charge Period for the Quote Item Price in their response.

- [O13] The Quote Item Term Duration specified by the Seller in their Quote MAY be greater than, equal to, or less than the Buyer's Requested Quote Item Term Duration.
- [R60] If the Quote Item Term Duration specified in the Seller's Quote is less than the Buyer's Request Quote Item Term Duration and the Quote moves to the Orderable states, the Quote Item State MUST be ORDERABLE_ALTERNATE.
- [R61] If the Seller's Quote includes an End of Term Action of ROLL for a Quote Item's Quote Item Term, then the Seller MUST specify the Roll Interval as shown in Table 17 for that Ouote Item.

[R63] The grace period after auto-renewal during which the Buyer can disconnect the Product without penalty MUST be agreed between Seller and Buyer as part of on-boarding if the Seller chooses to use the value "AUTO_RENEW" for the End of Term Action of the Quote Item Term.

9.1.2.2 Requirements for Create Quote Request with Immediate Quote Response = TRUE Seller Provides Immediate Response

The following requirements apply if the Seller Response Code indicates success.

- [R64] When providing a response to a Create Quote request with an Immediate Quote Response of TRUE, the Seller MUST include their Quote as described in section 6 in the Response.

- [R67] When providing a response to a Create Quote request with an Immediate Quote Response of TRUE and the Quote State indicates ORDERABLE or ORDERABLE_ALTERNATE, then for each Quote Item in the request, the Seller MUST specify the following Quote Items attributes defined in Table 15 that are set by the Seller in the Quote:
 - Quote Item State
 - Quote Item Price
 - Ouote Item Term
 - Quote Item Installation Interval
- [R68] If the Seller's Quote has a Quote State of ORDERABLE_ALTERNATE at least one of the Quote Items within the Quote MUST indicate a Quote Item State of ORDERABLE_ALTERNATE.



- [R69] A Quote Item with a Quote Item State of ORDERABLE_ALTERNATE MUST contain at least one of the following:
 - A Quote Item Term that is > the Buyer's Requested Quote Item Term
 - A Quote Item Installation Interval that is > the Buyer's Requested Quote Item Installation Interval

9.1.2.3 Requirements for Create Quote Request with Immediate Quote Response = FALSE Seller Provides Deferred Response

When providing a Deferred Response to a Create Quote request the Seller provides a response that is defined in requirements specified in section 9.1.2.1. This section defines the requirements for the Quote that the Seller makes available to the Buyer once the Seller has completed the Quote.

The following requirements apply if the Seller Response Code indicates success.

- [R70] When providing a Quote for a Create Quote request with an Immediate Quote Response of FALSE and the Quote state indicates ORDERABLE or ORDERABLE_ALTERNATE, then for each Quote Item in the request, the Seller MUST specify the following Quote Items attributes defined in Table 15 that are set by the Seller in the Quote:
 - Quote Item State
 - Quote Item Price
 - Quote Item Term
 - Quote Item Installation Interval

9.1.2.4 Requirements for Create Quote Request Immediate Quote Response = FALSE Seller Provides Immediate Quote Response

In this case, the Seller provides an Immediate Quote Response containing their Quote even though the Buyer did not mandate that an Immediate Quote Response be provided. The Seller's Quote must meet the requirements specified in sections 9.1.2.1 and 9.1.2.2.

9.2 Cancel or Decline Quote by Quote Identifier

The Buyer may Cancel a Create Quote request that is in progress or may Decline a Quote that the Seller has provided. The requirements are the same for both a Cancel Quote by Quote Identifier request and a Decline Quote by Quote Identifier request. A Buyer creates a Cancel Quote by Quote Identifier request or Decline Quote by Quote Identifier request and sends the request to the Seller. The Seller does not need to respond with an Accept or Decline. Instead, it is inferred that if the Seller Response Code indicates success, the Buyer's request has been accepted.



9.2.1 Buyer Cancel Quote by Quote Identifier Request or Decline Quote by Quote Identifier Request

This section contains the requirements for Use Case 4 and Use Case 5. Table 16 contains the attributes that the Buyer may set in the Cancel Quote by Quote Identifier request or Decline Quote by Quote Identifier request.

- [R71] A Buyer requesting to Cancel a Create Quote request, or Decline a Quote MUST include the following attributes defined in Table 16:
 - Seller Quote Identifier
 - Requested Quote State
- [O14] The Buyer Cancel Quote by Quote Identifier request MAY specify the Reason attribute in Table 16.
- [O15] The Buyer Decline Quote by Quote Identifier request MAY specify the Reason attribute in Table 16.

9.2.2 Seller Cancel Quote by Quote Identifier or Decline Quote by Quote Identifier Request Response

This section defines requirements for the Seller's response to a Cancel Quote request by Quote Identifier request or Decline Quote by Quote Identifier request. If the Seller Response Code indicates success, the request is considered accepted, and the Seller takes the appropriate action on the Quote.

- [R72] When providing a response to a Buyer Cancel Quote by Quote Identifier request or Decline Quote by Quote Identifier request, the Seller MUST specify the Seller Response Code attribute shown in Table 13.
- [R73] If the Seller Response Code indicates success, the Seller MUST take the following actions:
 - Set the Quote State to the Requested Quote State
 - Set the Quote DECLINED Date if Quote has been Declined
 - Set the Quote CANCELLED date if the Quote has been Cancelled

- [O16] The Buyer MAY use any of the following attributes specified in Table 13 for a Retrieve Quote List request:
 - Seller
 - Buyer
- [O17] The Buyer MAY use any of the following attributes specified in Table 14 for a Retrieve Quote List request:
 - Buyer Quote Identifier
 - Requested Quote Completion Date (range of dates)
 - Quote Request Date (range of dates)
 - Quote Completion Date (range of dates)
 - Quote State
 - Quote Level
 - Expected Quote Completion Date (range of dates)
 - Project Identifier
- [O18] The Buyer MAY use a combination of attributes to avoid getting a Too Many Records response code.

9.3.2 Seller Response to Retrieve Quote List Request

The Seller responds to the Retrieve Quote List request with the attributes shown in Table 13 and Table 14.

- [R74] When providing a response to a Retrieve Quote List request the Seller MUST specify the Seller Response Code attribute shown in Table 13.
- [R75] The Seller's response MUST include the following attributes specified in Table 13 for if they were specified in the Retrieve Quote List request:
 - Seller
 - Buyer



- [R76] The Seller's response to the Buyer's Retrieve Quote List request MUST contain the following attributes from Table 14 for each Quote that matches the filter criteria:
 - Seller Quote Identifier
 - Buyer Quote Identifier
 - Quote Request Date
 - Quote Completion Date
 - Quote Completion State
 - Quote State
 - Quote Level
 - Expected Quote Completion Date
 - Project Identifier
 - Requested Quote Completion Date
- [R77] If the Seller Response Code does not indicate success, the Seller MUST NOT reply with any of the attributes in Table 14.

In Table 30, Table 31, Table 32, and Table 33, the Quote and Quote Item attributes Echoed from the Buyer's Create Quote request are shown by an "E", Required to be provided by the Seller shown by an "R", Required if Populated by the Seller shown by an "PR", or Optional to be



provided by the Seller or the Buyer shown by an "O". Any cells that are left blank in the table indicate that the Seller does not include this attribute in their response.

The Seller's response to a Buyer's Register for Quote Notifications request uses the Seller Response Code from Table 13.

[R86] When responding to a Register for Quote Notification request, the Seller MUST specify the Seller Response Code attribute shown in Table 13.

If the Seller Response Code indicates success, then subsequent notifications are sent. If the Seller Response Code does not indicate success, the subsequent notifications are not sent.

9.6 Send Quote Notification

This section contains the requirements for Use Case 7. The following requirements apply to the Quote Notification.

- [O20] The Seller MAY support sending Quote Notifications.
- [CR4]<[O20] The Seller MUST be able to send Quote Notifications to Buyers for both Immediate Quote Responses and Deferred Quote Responses.
- [CR5]<[O20] If the Buyer has registered for QUOTE_STATE_CHANGE notifications, Quote Notifications for Immediate Quote Responses MUST be sent to the Buyer when a Quote has changed from the ORDERABLE_ALTERNATE or ORDERABLE states to one of the end states (DECLINED, EXPIRED, or ACCEPTED).
- [CR6]<[O20] The Seller MUST NOT send Quote Notifications to Buyers who have not registered for Quote Notifications.
- [CR7]<[O20] The Seller MUST send Quote Notifications to Buyers who have registered for Quote Notifications.
- [CR8]<[O20] Quote Notifications MUST include the Attributes shown in Table 27.
- [CR9]<[O21] The Quote Item Reference Number MUST be included in a QUOTE ITEM STATE CHANGE notification as described in Table 27.



10 Process Flows

10.1 Quote Process Flow

The Quote process flows are shown below. The diagrams capture various states that the Quote goes through in its lifecycle. The specific states are managed by the Seller based on its processing and/or based on Buyer's action. If the Buyer subscribes to Quote State change notifications, they will receive a Quote Notification every time the state changes. If the Buyer subscribes to Quote Item State change notifications, they will receive a Quote Item Notification every time the state changes.

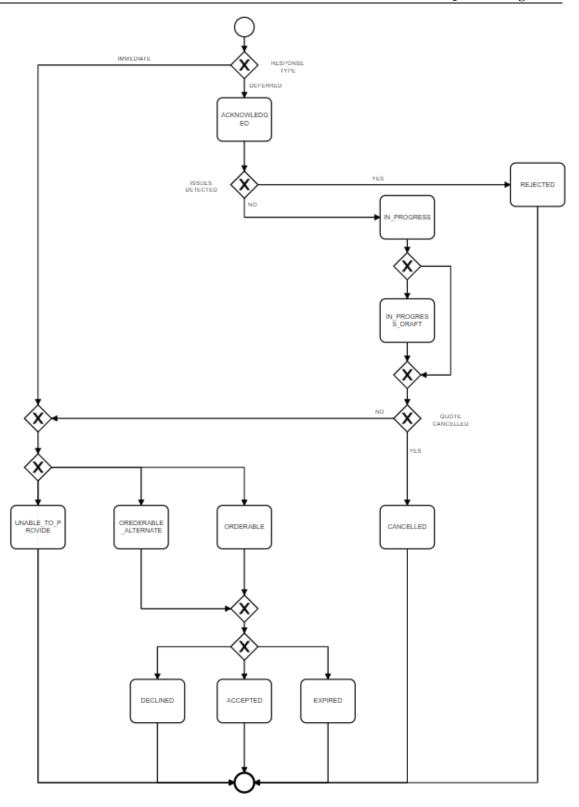


Figure 4 – FIRM Buyer Quote Level Quote Process Flow

- [R87] For a Quote with a Buyer Requested Quote Level of FIRM, the Seller MUST support Quote States and their associated state transitions as shown in Figure 4 and Table 34.

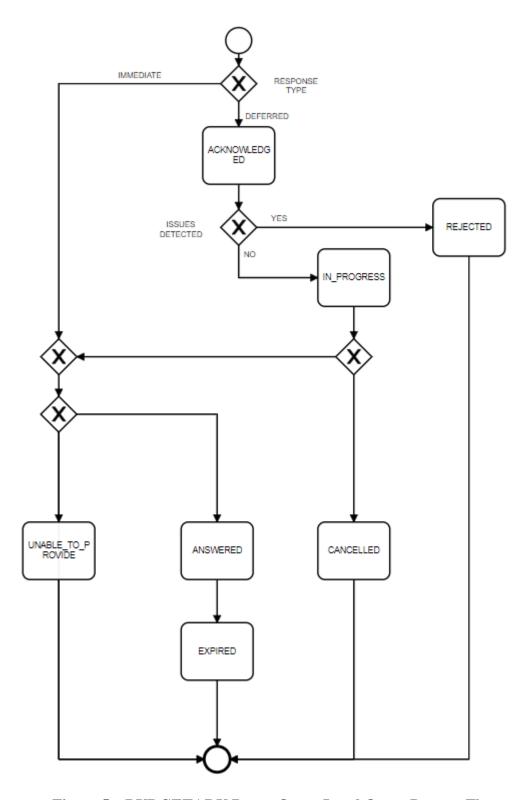


Figure 5 – BUDGETARY Buyer Quote Level Quote Process Flow

- [R88] For a Quote with a Buyer Requested Quote Level of BUDGETARY, the Seller MUST support Quote States and their associated state transitions as shown in Figure 5 and Table 35.
- [R89] For a Quote with a Buyer Requested Quote Level of FIRM the Seller MUST support Quote Item States, and their associated state transitions shown in, Figure 7 and Table 37.
- **[R90]** For a Quote with a Buyer Requested Quote Level of BUDGETARY the Seller **MUST** support Quote Item States, and their associated state transitions as shown in Figure 7 and Table 37.

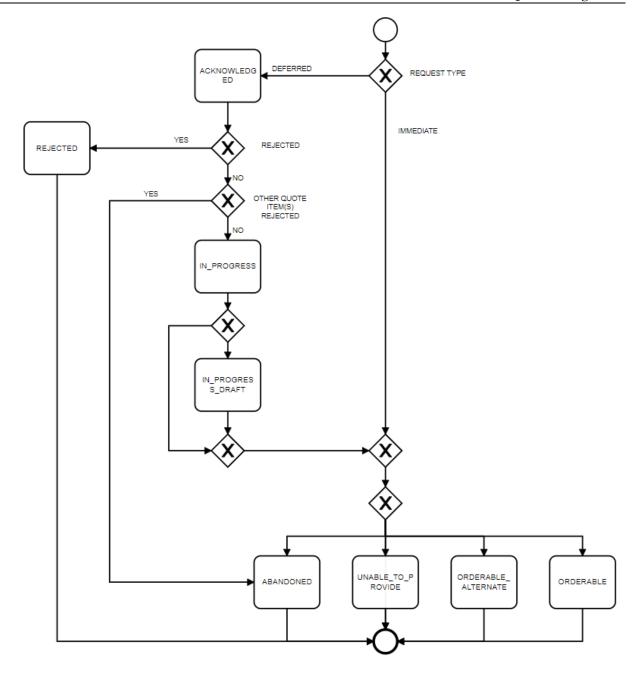


Figure 6 – FIRM Buyer Requested Quote Level Quote Item Process Flow

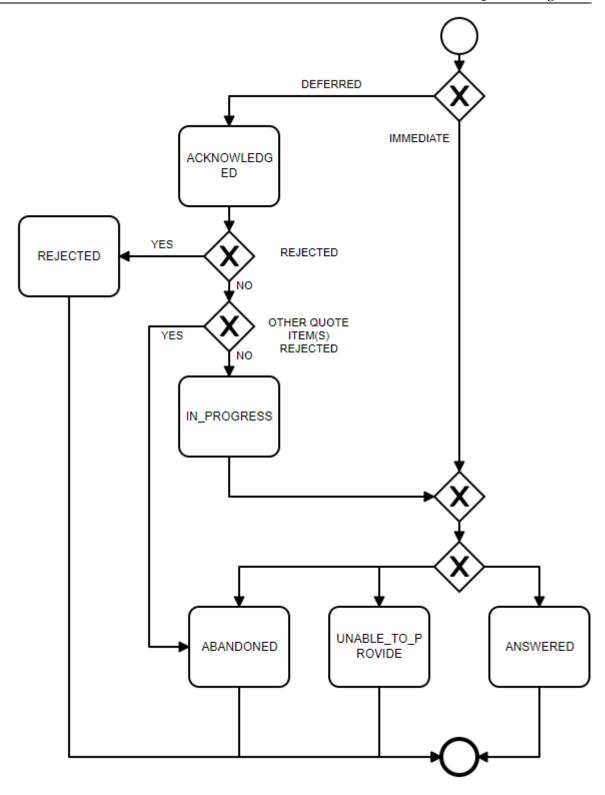


Figure 7 – BUDGETARY Buyer Requested Quote Level Quote Item Process Flow
